Quick Cash – Dare to Double Promotion



Terms & Conditions Effective 2025

TERMS AND CONDITIONS APPLICABLE TO THE GREENS THE ENTRANCE QUICK CASH – DARE TO DOUBLE PROMOTION:

The promotion is authorised under NSW Authority: **TP/04207**

1. The promoter is Mingara Recreation Club Ltd t/as The Greens The Entrance ABN 81 001 662 648.
2. The Quick Cash – Dare to Double promotion is only open to financial current Ordinary, Special, Life and Provisional members of The Greens The Entrance (the Club). However, the promotion is not open to any member whilst their membership is suspended.
3. Members who are un-financial are not eligible to participate or claim a prize in this promotion.
4. Members of other registered clubs that encompass Mingara Leisure Group (Mingara Recreation Club, The Westport Club, Lantern Club and Springwood Sports Club), are not eligible to participate or claim a prize in this promotion.

Promotional Period

5. The promotional period commences on and from 08:00 hours Monday 17 March 2025 and concludes Sunday 3 March 2029.

Promotion Entry Entitlements

6. A member is entitled to one (1) ticket in the Promotion for each one hundred (100) Reward Points which the member spends within the Club or at any participating outlet on the Club's licensed premises.
7. A member is also entitled to one (1) ticket in the promotion by swiping their membership card at any of the Membership Kiosks located throughout the Club's premises. A member is only entitled to one (1) ticket each day (00:00 hours to 23:59 hours).
8. A member may also be allocated bonus tickets, up to one hundred (100) tickets per occurrence, throughout the promotional period by participating in digital and Club promotions. These include but are not limited to attendance at events, the completion of online competitions and surveys and random swipe bonuses issued through The Greens The Entrance Membership Kiosks.
9. Multiple tickets are permissible in one (1) draw.
10. For a member to be entitled to a ticket(s) into the Quick Cash – Dare to Double promotion, they must redeem their tickets into entries to be eligible into the Promotion's draws. A member can only redeem their tickets into entries at one of the Membership Kiosks within the Club's premises. On each occasion, the tickets redeemed will reflect the entry/ies to which the member has become entitled since last redeeming tickets into the draw. A physical receipt of entry/ies will be issued to the member, showing the number of entries that have been redeemed, however, the binding evidence of an entry is the database record in the Club's relevant computer system, and not on any printed receipts.

11. Rights of entry into the Promotion can only be acquired and exercised during the Promotion Period as stated under the Promotional Period (in point 6 above).

Draw Details and Procedures

12. For any Monday Draw, rights of entry cease to accrue at 18:00 on the day of the Draw. Members must initiate tickets for any right of entry no later than 18:00 on the day of the Draw.
13. For any Wednesday Draw, rights of entry cease to accrue from 14:30 on the day of the Draw. Members must initiate tickets for any right of entry no later than 14:30 on the day of the Draw.
14. For any Friday Draw, rights of entry cease to accrue from 18:00 on the day of the Draw. Members must initiate tickets for any right of entry no later than 18:00 on the day of the Draw.
15. For any Sunday Draw, rights of entry cease to accrue from 14:30 on the day of the Draw. Members must initiate tickets for any right of entry no later than 14:30 on the day of the Draw.
16. For each Monday and Friday Draw, on the day of the Draw commencing at approximately 18:30, (three) 3 ticket numbers and corresponding member names will be drawn one by one and from the Club's eBet and/or applicable computer database systems. As each member's name is drawn it will be announced via the Club's public address system. For each Wednesday and Sunday Draw, on the day of the Draw commencing at approximately 15:00, (three) 3 ticket numbers and corresponding member names will be drawn one by one from the Club's eBet and/ or applicable computer database systems. As each member's name is drawn it will be announced via the Club's public address system
17. The member must be on the Club's licensed premisesⁱ at the time of the first announcement of the member name and membership number to be eligible to claim the prize.
18. The announced member must present themselves at the designated promotional stand within the Club's premises within 4 minutes of their name being called to claim a prize in the Draw, otherwise the announced member is not entitled to a prize. In that case a redraw will take place. This process will be repeated until the announced holder of the three (3) drawn tickets have duly presented themselves and have been acknowledged. The Club in its discretion may adjourn the process to continue at the next Draw date, if all prizes are not duly claimed by 21:30 for a Monday or Friday draw, or by 18:00 for a Wednesday or Sunday Draw.
19. For each Draw, the Club will choose a promotional theme that allows the holders of the three (3) winning tickets to randomly select one (1) prize from eight (3) available prizes. The prizes available at each minor draw are;
 - 1 x \$100 Cash
 - 2 x \$50 Cash

Quick Cash – Dare to Double – Double or Halve feature

20. At the time each Draw takes place, the winning member who receives one (1) or more of the three (3) cash prizes on offer, has the option to take the cash prize won, or play the Quick Cash – Dare to Double – Double or Risk feature.
21. The winning member is in no way obliged to play the Quick Cash – Dare to Double – Double or Risk feature.
22. To play Quick Cash – Dare to Double – Double or Halve feature, the winning member can choose to take the cash won, or play for a chance to double the Cash prize, or risk losing half of the Cash prize as per the following breakdown;
 - 1 x \$100 Cash prize *doubles to \$200 Cash or reduces to \$50 Cash*
 - 2 x \$50 Cash prizes *double to \$100 Cash or reduce to \$25 Cash*

23. The play component of Quick Cash – Dare to Double – Double or Halve feature is a game of chance with an equal (50/50) possibility to 'double' or 'halve' the Cash amount and is part of the Club's promotional theme.

Clearing of tickets from member accounts

24. All accrued Quick Cash – Dare to Double tickets on member accounts will be cleared at 14:30 on the last Sunday of each month.
25. Prior to 14:30 on the last Sunday of each month, members must redeem any accrued tickets or they will be cleared and ineligible for use in the promotion.
26. After 14:30 on the last Sunday of each month, members who spend their Reward Points, triggering Quick Cash – Dare to Double tickets to their account, will be able to redeem their tickets from 9am the next day until 14:30 on the last Sunday of the next month.

Proof of qualification and payment of prizes

27. A member claiming a prize must identify themselves and prove their identity and eligibility to the reasonable satisfaction of the Club, in order to participate, or for a prize to be awarded to them.
28. All prizes won in Quick Cash – Dare to Double will be issued to the winning member as cash by the team member or applicable staff of The Greens The Entrance who is running the promotion as cash only.

GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

29. The following persons are not eligible to participate in the promotion or win:
- (a) [Club officers; executives and families; other employees] - Club directors or auditors; Club executives (and the immediate family of any executive); other Club employees;
 - (b) [Contractors directly involved in the promotion, and families] - Officers and employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and the immediate family of any of them);
 - (c) [People who work on the Club's premises] - Persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club;
 - (d) [People working at the Club at the time] - Persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee.
30. Information on how to enter forms part of the promotion conditions.
31. The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. Certain areas within the main club building are excluded including any rooms in use for a private event at the time of the draws. The Club's car parks, bowling greens or any outer building detached from the main club building and entry area before the Reception/sign in desk do not form part of the Club's premises for the purposes of Club promotions.
32. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
33. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control

of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.

34. The Club's decisions in relation to the promotion may be made by Mingara Leisure Group's CEO or his/her delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club's CEO also may (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. Decisions by the Club's CEO, and subject to any countermanding decision by the Club's CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.
35. Members wishing to be sure of entry should seek to complete transactions and to initiate ticket printing early, to reduce the risk of being excluded because of any shortage of service points or because of delay or crowding.
36. The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members, or in the completion of entries to the promotion, or in seeking to attend any draw or to attend the process of selecting a winner.
37. The Club is not responsible for members being located in areas within the Club's premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements.
38. A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
39. The Club has no liability for acting on or broadcasting any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
40. Where the Club's decision is that a person claiming a prize is not eligible to participate or has not qualified to win the prize or, on the basis of these conditions, is not entitled to the award of a prize, the Club is entitled not to award the prize and the prize may remain at the same amount for another scheduled draw on that day/night or on the next draw day/night.
41. Prizes are strictly not transferable or negotiable.
42. The collection, use and disclosure of personal information provided to the Club in the course of the promotion is subject to these conditions and is otherwise governed by the Club's Privacy Policy. Please ask for a copy of that Policy if you are not aware of its contents. Members not wishing to participate in automatic draws should notify the Club's General Manager's office in writing as soon as possible.
43. If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.
44. Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting. The Club is not responsible for any such advice.
45. No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.
46. These conditions cannot be varied for an individual member.
47. The Club determines the designated clock from which draws are timed.
48. A person by claiming or accepting a prize, agrees that the Club may use their name, suburb,

photograph, image and likeness for the purpose of promoting the Club and agrees to co-operate with the Club to allow their photo to be taken for those purposes.

49. Neither the Club nor any of its officers, employees, contractors or agents, have any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
50. Members will be notified of this promotion through advertising in the Club's premises, PA announcements, social media, electronic communications or by other means at the Club's discretion. All advertising material will contain the approved Permit Number.

ⁱ The Club's licensed premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely the outdoor dining terrace and al fresco smoking area). The Club's car park and entry area before Reception/sign in area are not considered to form part of the Club's licensed premises for the purposes of Club promotions.
