THE GREENS THE ENTRANCE Members' Jackpot Promotion



Terms and Conditions Effective July 2025

TERMS AND CONDITIONS APPLICABLE TO THE GREENS THE ENTRANCE MEMBERS' JACKPOT PROMOTION:

The promotion is authorised under NSW Authority: **TP/04207**.

- 1. The promoter is Mingara Recreation Club Ltd, t/as The Greens The Entrance ABN 81 001 662 648.
- 2. The Members' Jackpot promotion is only open to financial current Ordinary, Special, Life and Provisional members of The Greens, The Entrance Club (the Club). However, the promotion is not open to any member whilst their membership is suspended.
- 3. Members who are un-financial are not eligible to participate or claim a prize in this promotion.
- 4. The eBet Random Draw System will be used to select membership numbers from the membership database. The Random Draw System forms part of the Netcash CCCE SQL system, a device approved by the NSW Liquor & Gaming. All membership numbers produced by the Random Draw System will be verified against the Club's current membership database to determine the eligibility of the number drawn.

Weekly Draws

- 5. Weekly draws will commence on Tuesday 1 July 2025 and run each Tuesday and Thursday until the jackpot reaches \$40,000 unless won earlier in which case this promotion and jackpot amount resets.
- 6. Members are automatically entered into the promotion by being a qualifying member in one of the above (point 3) membership categories.
- 7. The initial startup prize for the first draw in the first week of the promotion will be \$200. Once the prize has been won, it will reset to \$200.
- 8. One membership number will be drawn from the membership database at 6:30pm each Tuesday and Thursday during the promotion period. That membership number and corresponding member's name will be announced via the Club's PA system.
- 9. The announced member must be in attendance within the Club's premises and present themselves at the area designated for the conduct of this promotion within 4 minutes of their name being called to claim the prize, otherwise the announced member is not entitled to the prize and the prize is not awarded.
- 10. A member who enters the Club's licensed premises after the first announcement of the member name and membership number has been made is not eliqible to claim the prize.
- 11. If not duly claimed at the 6:30pm draw on either of the draw nights, a second draw will be conducted at 8pm on each of the weekly draw nights. The prize for the 8pm draw on any night will remain at the amount which was available at that night's 6:30pm draw. If the prize remains unclaimed after the 8pm draw, the prize will jackpot by \$200 to the next 6:30pm draw. The 8pm draw will otherwise operate in the same way as the 6:30pm draw.
- 12. If a member presents themselves at any weekly draw and they are compliant with the conditions of the permit, the member will win the jackpot prize amount.
- 13. The Club's premises are as determined by the Club in its discretion and comprise the licensed club building and designated outdoor areas (namely the outdoor dining terrace and all fresco smoking area). The Club's carpark does not form part of the Club's premises for the purposes of Club promotions. For clarification, to claim a prize, members must have their two feet passed the air lock doors (doors closest to Reception) when their name and membership number is called out during the first announcement.

Guaranteed \$40,000 Draw (only occurs if jackpot not won after 100 weeks)

14. If the jackpot reaches \$40,000 (after 100 weeks or 200 individual unclaimed weekly draws), weekly draws will continue to take place at \$40,000 for the following 6 weeks. Unless claimed during this 6 week period, a guaranteed jackpot draw will take place on the 6th Thursday from when the jackpot first hit \$40,000. The 6:30pm

and 8pm draws will go ahead as per normal on this night. If the jackpot is not claimed at the 6:30pm or 8pm draws, a guaranteed jackpot draw will take place at 8:15pm. To enter the 8:15pm draw, members will need to swipe their membership card at the Reward Kiosk from 4.30pm to 8pm on the day of the Guaranteed \$40,000 Draw. Members of The Greens The Entrance (as determined in point 3 above), who swipe their membership card will receive one (1) entry only into the guaranteed jackpot draw. From this pool of data, a member will be randomly drawn and announced. If the member does not claim the jackpot within 4 minutes, a redraw will take place. This will continue until a winner is determined. Once claimed, the jackpot will reset to \$200 and will continue to jackpot as normal.

Proof of qualification and payment of prizes

- 15. A member claiming a prize must identify themselves, sufficiently proving their identity and eligibility to the reasonable satisfaction of the Club in order to claim the prize awarded to them. A member may only claim a prize by presenting themselves personally at the designated promotion stand.
- 16. Prizes up to \$2,000 will be paid in cash within 1 hour of the prize being awarded. Any balance will be paid by Electronic Funds Transfer within 4 business days after the draw. The Club may require the member to provide documentary proof of identity to the Club's reasonable satisfaction for payment to proceed.

GENERAL TERMS AND CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

- 17. A The following persons are not eligible to participate in the promotion or win:
- (a) [Club officers; executives and families; other employees] Club directors or auditors; Club executives (and the immediate family of any executive); other Club employees;
- (b) [Contractors directly involved in the promotion, and families] Officers and employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and the immediate family of any of them);
- (c) [People who work on the Club's premises] Persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club;
- (d) [People working at the Club at the time] Persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee.
- 18. Information on how to enter forms part of the promotion conditions.
- 19. The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. Certain areas within the main club building are excluded including any rooms in use for a private event at the time of the draws. The Club's car parks or any outer building detached from the main club building and entry area before the Reception/sign in desk do not form part of the Club's premises for the purposes of Club promotions.
- 20. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
- 21. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.
- 22. The Club's decisions in relation to the promotion may be made by Mingara Leisure Group's CEO or his/her delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. Decisions by the Club's CEO, and subject to any countermanding decision by the Club's CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.
- 23. The Club will appoint one or more scrutineer/s for any draw or draws that have prizes with values exceeding \$10,000 or all draws or a prize process or all prize processes.
- 24. Members wishing to be sure of entry should seek to complete transactions and to initiate ticket printing early, to reduce the risk of being excluded because of any shortage of service points or because of delay or crowding.
- 25. The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members, or in the completion of entries to the promotion, or in seeking to attend any draw or to attend the process of selecting a winner.
- 26. The Club is not responsible for members being located in areas within the Club's premises in which PA

announcements are not able to be heard, nor for the audible integrity of those announcements.

- 27. A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
- 28. The Club has no liability for acting on or broadcasting any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
- 29. Where the Club's decision is that a person claiming a prize is not eligible to participate or has not qualified to win the prize or, on the basis of these conditions, is not entitled to the award of a prize, the Club is entitled not to award the prize and the prize may remain at the same amount for another scheduled draw on that day/night or on the next draw day/night.
- 30. Prizes are strictly not transferable or negotiable.
- 31. The collection, use and disclosure of personal information provided to the Club in the course of the promotion is subject to these conditions and is otherwise governed by the Club's Privacy Policy. Please ask for a copy of that Policy if you are not aware of its contents. Members not wishing to participate in automatic draws should notify the Club's General Manager's office in writing as soon as possible.
- 32. If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.
- 33. Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting. The Club is not responsible for any such advice.
- 34. No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.
- 35. These conditions cannot be varied for an individual member.
- 36. The Club determines the designated clock from which draws are timed.
- 37. A person by claiming or accepting a prize, agrees that the Club may use their name, suburb, photograph, image and likeness for the purpose of promoting the Club and agrees to co-operate with the Club to allow their photo to be taken for those purposes.
- 38. Neither the Club nor any of its officers, employees, contractors or agents, have any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
- 39. Members will be notified of this promotion through advertising in the Club's premises, PA announcements, social media, electronic communications or by other means at the Club's discretion. All advertising material will contain the approved Permit Number
