

# THE GREENS THE ENTRANCE GOLDEN TICKET CASH DRAW TP/04207 NTP/15798

## Terms and Conditions

### General

1. Information on how to enter and prize form part of the Terms and Conditions of Entry. Entry into this competition is deemed acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

### Who can enter

3. Subject to the clauses below, entry is open to members of The Greens The Entrance who have fulfilled the requirements below ('Eligible Entrants'). Entrants must be over 18 as of the date of entry and members of The Greens The Entrance.
4. The following are not eligible to enter the promotion: The Mingara Leisure Group Executive Team (and their spouses and immediate family), The Club General Manager (and their spouses and immediate family), Mingara Leisure Group Directors or auditors, contractors directly involved in the promotion (and their spouses and immediate family), employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion (and their spouses and immediate family), people who work on the Club's premises including the Club's onsite Business Partners, persons whose usual place of work is within premises owned or leased by the Club, who are employed by any of the licensees or lessees of the Club, persons employed by any other supplier or contractor of the Club who at or about the time of a particular draw, are on the Club's premises in that capacity as such an employee.

### How to enter

6. Entry into this competition is free. To enter, Eligible Entrants must, during the Promotional Period (defined below in clause 12).
7. The Greens The Entrance Golden Ticket Cash Grab is a weekly promotion that occurs every Friday night with a Major Draw event every 12<sup>th</sup> draw night.
  - Ticket Redemption must occur by 6:45 PM the Friday evening of the draw
  - Draw Start: 7:00 PM, then draws will occur every 10 minutes. Member must be present to win
  - Five names are drawn each draw night
  - Draw times: 7:00 PM, 7:10 PM, 7:20 PM, 7:30 PM, 7:40 PM
  - When drawn out, winners receive a number that determines their prize pick order for the 5 Golden Tickets
  - At 8:00 PM, winners choose from 5 Golden Tickets with cash prizes totaling in \$1,500

When a member's number is drawn their name will be announced over the PA system throughout the venue by a promotions team member. They will have 4 minutes to come to the activation point and identify themselves to be a contestant. They must present their valid Club membership card.

**8.** If the selected member does not identify themselves within the allotted 4 minutes another ticketed redemption member is drawn from Ebet. This process will occur until a contestant makes themselves known.

**9.** At the weekly 8pm draw the contestant will select one Golden Ticket in the predetermined order (outlined on clause 7). Tickets are selected from the promotion display by the winner, with the underside of Golden Tickets reveals the cash amount won. If a winner from the nights previous draws @ 7:00pm, 7:10pm, 7:20pm, 7:30pm, or 7:40pm is not present at 8 pm, another member will be drawn from that week's pool to participate in the 8pm draw.

**10.** On the night of the Major Draw, a final regular Weekly Draw will take place as per clause above. At the Major Draw, the 12 previous weekly contestant winners will select a face down card in the order of the week in which they won. The 12 cards are numbered 1 to 12, which will determine the order of the winner's key selection. The winners then select 1 of 12 numbered keys in the order of the numbered cards picked. The winners will attempt to unlock the safe. The winner with the correct key that unlocks the safe, wins the \$5,000 cash, will all other participants winning \$50.

#### **Number of entries permitted**

**11.** Multiple entries may occur until throughout the promotional period.

#### **Promotional period**

**12.** The competition commences on Friday 01 May 2026 and ends Friday 03 May 2030 ('Promotional Period').

**13.** The winner will be notified at the time of the weekly draw. Following successful claim of the prize, their name will also be published on The Greens The Entrance [Facebook](#) and Instagram pages.

#### **Further Terms and Conditions**

**15.** Any entrant found to have used a third party to enter on their behalf will have all entries invalidated, and any claim they have to any prize will be invalidated. If such an entrant is awarded a prize and then found to have breached this clause, the entrant must immediately return any prize awarded.
